# The Asan Institute to Host 'Asan Transitional Justice Conference 2013' On Transitional Justice in a Reunified Korea: Peace-Building & Reconciliation

The Asan Institute for Policy Studies will host the *Asan Transitional Justice Conference 2013* titled, "Transitional Justice in a Reunified Korea: Peace-Building & Reconciliation" on May 23 (Thurs.) – 24 (Fri.) at the Asan Institute's Washington, D.C. branch located at the Stimson Center.

For a two-day conference, 20 leading scholars and experts on North Korea, human rights and transitional justice, including Ruti Teitel from NYU, Muna Ndulo from Cornell University, Rajiv Narayan from Amnesty International, and Roberta Cohen from the Committee for Human Rights in North Korea, will gather in Washington, D.C. to have in-depth panel discussions on:

- peace-building and reconciliation in a reunified Korea;
- dealing with human rights atrocities in the DPRK;
- role of international actors in transitional justice
- learning from the experience of other countries; and
- transitional justice for a reunified Korea

In addition, Shin Dong-hyuk, a North Korean defector who is the only person known to have escaped from a "total-control zone" grade internment camp in North Korea, will testify the human rights violation.

No one knows when Korean reunification will take place. However, when it does, undertaking a fair and transparent process regarding the matters of transitional justice will be one of the key elements for peacebuilding and reconciliation in the reunified Korea. This conference seeks to examine the implementation of transitional justice mechanisms in the Korean context by bringing together renowned experts on transitional justice, North Korea, and human rights to examine the issue of transitional justice in reunified Korea.
